## APPLICATIONS:

- Removes bird droppings from outdoor surfaces

## DIRECTIONS:

**Do not mix with bleach.**

**Bird Dropping Cleaner:** Dilute 5 to 10 parts water to 1 part EVO, depending on amount of soil. Using a power washer or hand sprayer spray surface to be cleaned and allow time to soak. Rinse with water. If droppings are not immediately removed when rinsed, a second application and soak cycle may be necessary. NOTE: If area is sanitized following application of EVO microbial activity may be impaired.

**Enzyme Drain Degreaser:** Dilute 12 oz. with 2 gallons of water into a foaming pump up sprayer. For optimum results, treat drains weekly.

**Floor Cleaner:** Add 5 oz. to a mop bucket containing 3 to 5 gallons of water. Apply liberally to floor. Dry mop to pick up excess solution. Pour used mop water down troubled drains.

**Pressure/Power Wash Pretreatment:** Apply directly to oily or greasy buildup area using 32 oz. spray bottle or hand sprayer at a 7:1 dilution rate. Let stand for 1 to 2 minutes then rinse treated areas with pressure or power washer. If necessary, repeat application to completely remove buildup.

**Wastewater Treatment:** Apply with peristaltic monitored pump or pour directly into lift stations and lagoons.

## SAFETY ON METALS:

This product can be used in its diluted form on anything that can safely be washed with water.
