

DAILY CLEANER & DEGREASER

GENERAL DESCRIPTION:

Use as the first line of defense in the battle against slippery floors. This hard surface floor cleaner greatly improves surface traction, reduces the occurrence of polymerization, when used daily, and leaves surfaces residue free.

DIRECTIONS:

Daily Maintenance: Dilute 2 oz. per gallon (1:64) with water. It is recommended that a proportioning system is used. Using a clean, heavy-duty cotton or blend mop head and commercial-type mop bucket, thoroughly mop floor. Rinse mop head regularly and wring out excess solution.

Heavy Soil or Degreasing: Dilute 4 oz. per gallon (1:32) with water. Apply solution to floor using a mop or foam gun. Let solution soak for 5 to 10 minutes or longer. More dwell allows the solution to work on dirt and grease buildup. Scrub the floor thoroughly using a deck brush or electric scrubber. Rinse and damp mop dry with a fresh mop and clean water. If cleaning a large area with adequate drainage, rinse, squeegee into drain and damp mop dry.

Auto Scrubber Machine (with wet Vacuum Attachment):Dilute 1 oz. per gallon (1:128) with water. Clean floor

pursuant to the machine manufacturer's instruction.

SAFETY ON MATERIALS:

Always test on an inconspicuous area to make sure the cleaning agent does not adversely affect or damage the surface to be cleaned.

PRECAUTIONS:

HANDLING and STORAGE:
